Announcing the Competitive Entrance Examination and fixing the number of places available for admission into the first Year of **Professional Masters in Quality Control and Management (CGQ), Applied Nutrition (NA) and Maintenance and Management of Cooling and Heating Systems (MAIN-GEFT)** of the Doctorate and Specialisation cycle of National School of Agro-Industrial Sciences (ENSAI) of the University of Ngaoundere for **2021/2022** academic year.

On the proposal of the Rector of the University of Ngaoundéré,

DECIDES:

Article 1: A competitive Entrance Examination through study of files for admission of **ninety** students into the first Year of **Professional Masters in Quality Control and Management (CGQ), Applied Nutrition (NA) and Maintenance and Management Cooling and Heating Systems (MAIN-GEFT)** of the Doctorate and Specialisation cycle of The National School of Agro-Industrial Sciences (ENSAI) of the University of Ngaoundere for **2021/2022** academic year.

Article 2: the said competitive entrance sited in article 1 is opened to Cameroonians of both sexes and also to foreigners fulfilling the required conditions.

Article 3: The **ninety (95) places** offered are partition as follows:

Field of Specialisation	Number of places
Quality Control and Management	35
Applied Nutrition	30
Maintenance and Management of Cooling and Heat Systems	25

Article 4: Candidates for the examination should be holders of one of the following qualifications:

a) Candidates applying for "Quality Control and Management":

First Degree in any Science discipline; Bachelor of Technology; Professional Degree; Engineering Diploma; any other equivalent qualification recognised by the Ministry of Higher Education.

b) Candidates applying for "Applied Nutrition":

First Degree in any Science discipline; Bachelor of Technology or Professional Degree in Biochemistry, Nutrition, Nursing; Engineering Diploma; any other equivalent qualification recognised by the Ministry of Higher Education

c) Candidates applying for "Maintenance and Management of Cooling and Heat Systems:

Bachelor of Science in Physics; Bachelor of Technology or Professional Degree in Industrial Maintenance, Energetic and Heat; Engineering Diploma; any other equivalent qualification recognised by the Ministry of Higher Education

Article 5: (1) Application form can be obtained from the following sources:

- MINESUP/Office of University Accreditation and Quality;
- Regional Delegations for Secondary Education
- The University of Ngaoundere antennas in Yaounde (Immeuble Resistance Construction : Quartier Fouda), Bertoua and Garoua

(2) The complete application file should be **deposited solely** at the ENSAI – Ngaoundere Secretariat on or before the **30 September 2021**, and should contain the following:

- A duly filled and stamped (1000 frs) application form;
- A certified photocopy of birth certificate dated not more than three months old;
- A certified true photocopy of certificates/diplomas;
- A medical certificate issued from a government hospital dated not more than 3 months
- 4 recent passport-size photographs;
- A certified copy of your national identity card

- A receipt of payment of the sum of twenty thousand (20 000) francs into the bank BICEC n° 33696373001 – 95).
- 2 addresses (names, grade or title, telephone contacts and e-mails) of referees (Academic Personalities) to be contacted in case of need
- An A4 size self-addressed and 500 francs – stamped envelope.

Article 6: After publication of results, successful candidates will have a maximum of 10 working days to present themselves and complete admission modalities. After the said period, they will be replaced by those on the waiting list in order of merit.

Article 7: The Rector of the University of Ngaoundere, the Director of University Accreditations and Quality of the Ministry of Higher Education and the Director of ENSAI are responsible for the execution of this decision.
