4) A medical certificate issued within the last three (03) months by a state medical practitioner and testifying that the candidate is fit for higher education;

5) Two (02) recent passport-size photographs of the candidate;

6) A twenty thousand (20 000) CFA francs banking receipt being examination fees to pay at the UBA account N° 10033 05214 1400400006 – 90, or the BICEC account N° 01253101002-18;

7) A 21 x 29.7 size self-addressed envelope bearing a CFAF 400 postal stamp, bearing the address of the candidate;

8) A regular photocopy of the National Identity Card.

<u>Article 5</u>: Successful candidates shall report to UIT for registration formalities within fifteen days following the date of publication of the final results.
