SPECIMEN PAPERS FOR THE UPDATED CURRICULUM

This circular is accompanying specimen papers for the updated curriculum. It also serves to give guidance on the **November 2018 Ordinary and Advanced Level** public examinations in selected learning areas under the following groupings:

- Sciences
- Technicals
- Humanities
- Commercials

Except for practical and technical subjects, the November 2018 public examinations shall not include continuous assessment.

Traditionally, practical projects/course work has been carried in practical and technical subjects. For the November 2018 examination, centres are still required to submit projects to ZIMSEC as specified in this circular.

Where there are no specimen papers provided, the examination format is as in the old curriculum.
