SECTION A (Pre-Colonial to 1900)

1. In what ways and to what extent have Indigenous Knowledge Systems (IKS) contributed to food security among pre-colonial Zimbabwean societies?
2. Examine the economic changes that were brought about by the introduction of iron in the Early and Later Iron Ages.
3. To what extent did Portuguese-Swahili merchant capitalism affect the economy of the Mutapa from the sixteenth to the eighteenth centuries?
4. 'An entirely raiding economy.' Is this a justified view of the Ndebele economy between 1840 and 1893?
5. Compare the economic impact of the Anglo-Ndebele War of 1893 – 4 with that of the First Chimurenga/ Umvukela of 1896 – 7.

SECTION B (1901 to 1980)

6. Discuss the effectiveness of the methods used by the settlers to solve the shortage of labour between 1900 and 1930.
7. Assess the economic impact of the Land Apportionment Act of 1930 on African societies in colonial Zimbabwe.
8. Examine the economic arguments put forward by the settlers for the establishment of the Federation of Rhodesia and Nyasaland in 1953.
9. Compare the economic effects of the Land Husbandry Act of 1951 with those of the Land Tenure Act of 1969.
10. Assess the economic impact of the imposition of sanctions on colonial Zimbabwe between 1965 and 1980.

SECTION C (1981 to 2000)

11. Examine the measures taken by the government of Zimbabwe to develop agriculture between 1981 and 1990.
12. Why and with what effect did the government of Zimbabwe adopt the Economic Structural Adjustment Programme (ESAP) in 1991?
13. 'The bread basket of Africa.' Explain how Zimbabwe achieved that status between 1981 and 2001.
14. Assess the impact of the AIDS pandemic on the economy of Zimbabwe between 1990 and 2000.
15. Evaluate the response of the state and non-state actors to natural disasters in Zimbabwe between 1981 and 2000.

SECTION D (2001 to Present)

- 16.** Assess the role played by the government of Zimbabwe in the sustainable utilisation of the country`s resources since 2001.
- 17.** ‘Lack of business ethics has hampered the growth of a once vibrant Zimbabwean economy since 2001.’ Discuss.
- 18.** Examine the view that the mushrooming of Small to Medium Enterprises (SMEs) has threatened the viability of the formal business sector in Zimbabwe since 2001.
- 19.** ‘The introduction of a multi-currency system in Zimbabwe in 2009 brought relief to an ailing economy.’ How far do you agree with this view?
- 20.** How far has the Look East Policy helped in alleviating the economic challenges facing Zimbabwe?
