TO LAUNCH THE COMPETITIVE ENTRANCE EXAMINATION INTO THE **THIRD YEAR OF THE ENGINEERING TRAINING PROGRAMME AT THE NATIONAL ADVANCED SCHOOL OF ENGINEERING OF YAOUNDE (NASEY), AND TO SPECIFY THE NUMBER OF PLACES AVAILABLE FOR THE 2022/2023 ACADEMIC YEAR.**

**HEREBY ANNOUNCES:**

**Article 1:** A competitive entrance examination for the admission of **forty' (40) students** into the **third year of the engineering training programme** (Civil Engineering, Electrical Engineering, Industrial Engineering, Computer Engineering, Mechanical Engineering, Telecommunications Engineering, Meteorology) at the National Advanced School of Engineering of Yaounde (NASEY) for the **2022/2023** academic year has been launched to be written at the unique **Yaoundé** examination center. The examination shall consist of four (04) hours of a written paper in Mathematics, four (04) hours of a written paper in Physics, and four (04) hours of a written paper in Computer Science, all of equal rating.

**Article 2:** The competitive entrance examination is open to:

- Candidates who are holders of a first degree in any of the following: Engineering, Physics, Computer Science, and Mathematics. Candidates may also be holders of diploma from a University Institute of Technology (DUT) or Faculty of Science (DEUG) or any other equivalent diploma recognized by the Ministry of Higher Education.
- Candidates awaiting results for one of the above-mentioned certificates.

**Article 3:** The syllabus for the examination shall be the same as those of the classes leading up to the above-mentioned qualifying certificates or diplomas of type "Baccalaureate+2".

**Article 4:** The application file shall include the following documents:



1. An online individual record form duly filled by the candidate on the entrance examination page of the School's website: <http://www.polytechnique.cm/concours>;
2. A photocopy of the National Identity Card;
3. A certified true copy of the birth certificate (not more than 3 months old);
4. A certified true copy of the required certificate or an Attestation of success where applicable;
5. A certified true copy of the GCE-A/L certificate;
6. Transcripts for the last three years spent in the University or Higher Institution which issued the Certificate or Attestation of success;
7. A curriculum Vitae and Studiorum;
8. 4 passport size photos 4 x 4;
9. A self-addressed A4-size stamped (1 000 francs CFA) envelope;
10. A medical certificate of physical fitness delivered by a state registered medical doctor;
11. An authorization from the employer for successful candidates who are workers.

**Article 5:** The examination fee of **twenty five thousand (25 000) francs CFA** shall be payable through **EXPRESS UNION** in exchange for a receipt. The receipt must be attached to the candidate's application file. The examination fee which is non-refundable shall be used in covering expenses related to the organization of the examinations. **Any other means of payment shall not be accepted.**

**Article 6:** The complete application file shall reach either the Admissions Office of the National Advanced School of Engineering of Yaounde, P.O. 8390 Yaounde, or the Regional Delegation of The Ministry of Secondary Education of the candidate's place of residence, **latest the 12 of July 2022**. However, foreign candidates of countries in the CEMAC Zone shall deposit their files at the office of the Cameroonian diplomatic representatives in their respective countries.

**Article 7:** Only candidates who have submitted complete application files within the specified deadline will be called upon to sit for the examination. They are therefore requested to come along with their **National Identity Cards** which must be presented to the examination authorities.

**Article 8:** (1) The examination will take place on the **20 and 21 of July 2022** in the Yaounde examination centre.

(2) At the end of the deliberations, the jury setup by the Minister of State, Minister of Higher Education, will draw up a list of candidates proposed for final admission in order of merit, which will be published by the Minister of State, Minister of Higher Education.

**Article 9:** The Rector of the University of Yaounde I, the Director of the Department of University Accreditations and Quality, and the Director of the National Advanced School of Engineering of Yaounde, each in his own sphere, are responsible for the implementation of this Press Release which shall be registered and published in English and French, wherever necessary.
